a. Central Library

D. Financial Report

October 2021 Operating and Construction Funds

As of October 31, 2021, the Operating Fund revenue was \$7,599,199, and expenditures were \$7,997,541. It was noted that the expenditures include \$2 million transferred at the beginning of 2021 to the Construction Fund. The ending fund balance was \$5,374,138.

As of October 31, 2021, the Construction Fund revenue was \$2,017,293 and expenditures were \$388,122. The ending fund balance was \$9,839,576.

Motion made by Mr. Rimmer, seconded by Mr. Gray, to accept the October 2021 Operating Fund and Construction Fund reports. Motion carried unanimously.

Proposed 2021 Amended Budget

The board was presented with the proposed 2021 Amended Operating and Construction Budgets for review and consideration.

Motion made by Mr. Brotherton, seconded by Mr. Gray, to accept the proposed 2021 amended Operating and Construction Budgets. Motion carried unanimously.

E. Director's Report

Appointment of 2022 Board Officers

The president took nominations for the 2022 Board President.

Motion made by Mr. Rimmer, seconded by Mr. Morris, to nominate Mr. Brotherton for the 2022 Board President. Motion carried unanimously.

The president took nominations for the 2022 Board Vice-President.

Motion made by Mr. Brotherton, seconded by Mr. Gray, to nominate Mr. Rimmer for the 2022 Vice-President. Motion passed unanimously.
